1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
3. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 5. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

7. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

**1. Generic**

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

**2. Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

### 4. **Payment**

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

### 6. **Forms of EMD and PBG**

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

### 7. **Certificates**

## **SOW / ADDITIONAL TERMS AND CONDITIONS**

The terms and conditions are in reverse order of precedence i.e. ATC supersedes STC which super sede GTC, in case of any conflicting provisions.

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice t

o Seller, if : -

- 1) The Seller fails to comply with any service terms of the contract.
- 2) The Seller becomes bankrupt or goes into liquidation.
- 3) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the letter of acceptance on the Seller.

**Buyer added Bid Specific ATC**

- 1) Driver should be in uniform with having agency name and logo (if any)
- 2) In the event of a bus breakdown or non-availability of the bus, the service provider shall arrange a replacement bus within **30 minutes** at the location specified by the Buyer. In case of failure to provide the replacement bus within the stipulated time, a penalty of ₹1,000 per incident shall be imposed and deducted from the running bill, along with a warning issued to the service provider.
  - a) First instance - @ Rs. 1000/- per incident
  - b) Second instance - @ Rs. 2000/- per incident
  - c) Third instance - @ Rs. 5000/- per incident ..... and so on
  - d) If the same is repeated / more than three times, on the sole discretion of buyer to terminate the services without giving any notice / dues in lieu of thereafter or impose more penalty over and above.
- 3) If going outstation then toll charges will be paid extra, after submitting toll receipts with running bill, the bill submission of the bus will provide supporting document of daily log book for verification.
- 4) Also, driver will ensure opening & closing kilometres to be verified and signed by GSV officials / user (daily check).
- 5) Registered address of the agency (service provider) shall be of Vadodara.
- 6) Gati Shakti Vishwavidyalaya has the right to cancel / terminate the bus service fully or partly at any stage from the date of LOA, by providing 1-month notice period, on mutual consent basis.
- 7) All safety kit, fire extinguisher, air freshener, first aid should be available all time with regular refilling.
- 8) Driver should have and carry valid driving licence, permit, PUC Certificate, Copy of Insurance Certificate, Copy of RC book, etc. of the bus along with all documentary proof and one photo copy of the same shall be submitted in the office of buyer.
- 9) The vehicle provided to buyer should have a valid registration with RTO and must be insured to cover third party liability and insurance of passengers travelling in bus. Insurance policy should be valid and incorporate damage to vehicle, passengers, buyer(s) property etc.
- 10) Tool kit for maintenance / breakdown of bus should be available in bus all the time and will be regularly checked and inspected by buyer
- 11) Duration of service contract may be extended up to 01 years beyond the initial contract duration (subject to satisfactory performance and mutual consent).
- 12) The invoice shall be raised by seller as per GST Act.

- 13) Payment shall be made on actual usage.
- 14) The Bus Offers by the bidders should not older than 2023.
- 15) At the finalisation stage (during Financial Evaluation) Reverse Auction option is open for GSV, may negotiate the rate before finalising tender.
- 16) Driver shall not consume Alcohol, Tobacco and any other intoxication during the duty hours.
- 17) Successful bidder shall submit Performance Bank Guarantee for 26 Months.

**The important clauses in case of accidents, fatalities, injuries, or any major mishap**

- 18) **Contractor's Sole Responsibility Clause :** The contractor shall be solely responsible for the safety and security of students, staff, drivers, conductors, and any third party during operation of the buses. Any accident, injury, death, loss, or damage arising out of the operation of the vehicles shall be the sole responsibility of the contractor.
- 19) **Indemnity Clause :** The contractor shall indemnify and keep indemnified the University, its officers, employees, and students against all claims, liabilities, losses, damages, compensation, legal proceedings, costs, and expenses arising from any accident, injury, death, negligence, or breach of statutory provisions during execution of the contract.
- 20) **Compensation Liability Clause :** Any compensation payable under the Motor Vehicles Act, Workmen Compensation Act, or any other applicable law due to an accident involving the hired vehicles shall be borne entirely by the contractor and the University shall have no financial liability whatsoever.
- 21) **Emergency Response Clause :** In case of any accident or emergency, the contractor shall immediately arrange medical assistance, inform the University authorities and local police, and take all necessary steps for rescue and rehabilitation of affected persons.

13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues

or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.
